

The Maintenance Report

- *Roofs* The board approved \$8,480 to replace broken roof tiles and mudballs throughout the community.
- *Townhome Water Drainage Project* The gutter/downspout installation was put to the test during the recent rainstorm. Rainwater was successfully diverted. "All hail the monsoon".
- *Stucco Repairs* Common areas and residents' requests for stucco repairs are in progress.
- *Water Fountain* The water fountain station in the pool area has been removed. The cooling unit was not working, and the fountain was seldom used. The repairs would have been costly.
- *Next committee meeting* September 18, 2023, via Zoom.



Tesoro Reserve Study

The Board approved the July 2023 *Tesoro at Grayhawk HOA Reserve Study*. A copy has been uploaded to the Tesoro website under the *Members* section, *Current Year*.

Strong progress was made over the past year to reinforce the funding of Tesoro's reserves. There are still many challenges going forward.

There are three primary factors that have led to our estimated reserve funding of approximately 50% come January 2024. Significant underfunding in previous years, aging of the community infrastructure, now 20 years old, and the dramatic increases in inflation.

Frequently Asked Questions

The CC&R Amendment #4 - Capital Contribution Assessment The Who, What, Why, Where and When

What is it and Who pays it? It's a fee (0.25%) of the sale price, paid by the buyer to Tesoro HOA from the sale or transfer of a unit's ownership.

Where do the funds go and **Why**? The funds will be deposited into the Tesoro *Reserve Account* to support future capital needs and may proportionately reduce the amount of future HOA annual assessments.

When will this start? The board approved the final language for the <u>proposed</u> amendment at the March Board of Directors meeting. Per the CC&Rs, approval of the amendment requires 2/3 of the Tesoro owners "yes" vote.

Next steps

During the upcoming September 27th Executive Board meeting, the board will finalize details of the rollout plan for the Capital Contribution Assessment vote.

A Townhall meeting is planned for Saturday, October 28, 2023.

Important Traffic Information

Grayhawk Drive Pavement Project

The Retreat Village Association Board of Directors has approved a major street reconstruction project for Grayhawk Dr. from September 25 through October 20, 2023. This project will *affect Tesoro residents* exiting through the Hualapai gate during various points of the project as milling, paving, repairs, and striping occur.

Talon Retreat

- All traffic will enter through the Thompson Peak Parkway entrance and exit onto Hualapai Drive September 25-October 6.
- All traffic will enter through Hualapai Drive and exit onto Thompson Peak Parkway October 9-October 20.
- All neighborhood entrances off Grayhawk Drive will remain open during the project.
