Tesoro Townhall Meeting Recap

The townhall meeting held on October 28th was productive and informative. The Board of Directors held a frank discussion regarding Tesoro's finances with a well-attended group of residents. During the October regular board meeting, the 2024 Budget was approved. Five financial models were presented from #1 "no change" to #5 the greatest increase to assessments to cover "increased operating expenses plus reserve contributions as indicated in the <u>Reserve Study</u>". Ultimately the board approved scenario #2 which included an increase in assessments to cover "increased operating expenses" but with no increase to the reserve contribution. In 2024 Villa assessments will be \$415.00 (a \$15.00 or 3.8% increase). Townhome assessments remain at \$340.00*.

**Note*: Townhomes pay separately for some services that are included in the villa monthly assessment. The upcoming *CC&R Amendment Capital Contribution Assessment (CCA)* was reviewed and included a lively discussion with several residents offering their insights, opinions, and concerns regarding the "escalator clause." There was a common appeal from residents in attendance for the board to revisit the clause and consider its removal. After a special meeting of the board later in the week, the board authorized the removal of the escalator clause.

Finances are always a topic for concern, and both the board and residents are to be commended for their respectful and mutually beneficial resolution. Thank you to the board for their continued transparency and honesty and to the Tesoro residents for their informative comments and active participation. Tesoro is a community of talented individuals working collaboratively to create a desirable environment many chose to call home.


